Be as terse as possible - don't add content that can be inferred because it adds technical debt unnecessarily. 2. The definition of any concept should only include intrinsic properties, not extrinsic properties, so for example, if an identifier is not intrinsic to the nature of something, do not add x is identified by y to the set of restrictions on that thing. Because an identifier intrinsically identifies something, the inverse will be inferred. 3.
